Present was Gary Blindauer, Paul Larson, Steve Larson, and Rod Weber. Auditor Diane Larson and Deputy Auditor Kami Moody were also present. Motion by P. Larson, seconded by S. Larson, to approve the minutes as presented. Motion carried.

Motion by S. Larson, seconded by Blindauer to approve the minutes from the Special Meeting on January 22nd, as presented. Motion carried.

HIGHWAY
