Sanborn County Commissioners met in regular session on Tuesday, May 24, 2022, at 9:00 am, with Chairman Jeff Ebersdorfer presiding. Present were P. Larson, Gary Blindauer, and Rod Weber present. Steve Larson was absent. Auditor Kami Moody was also present. Motion by Blindauer, seconded by Weber, to approve the minutes from May 10 meeting, as presented. Motion carried.
